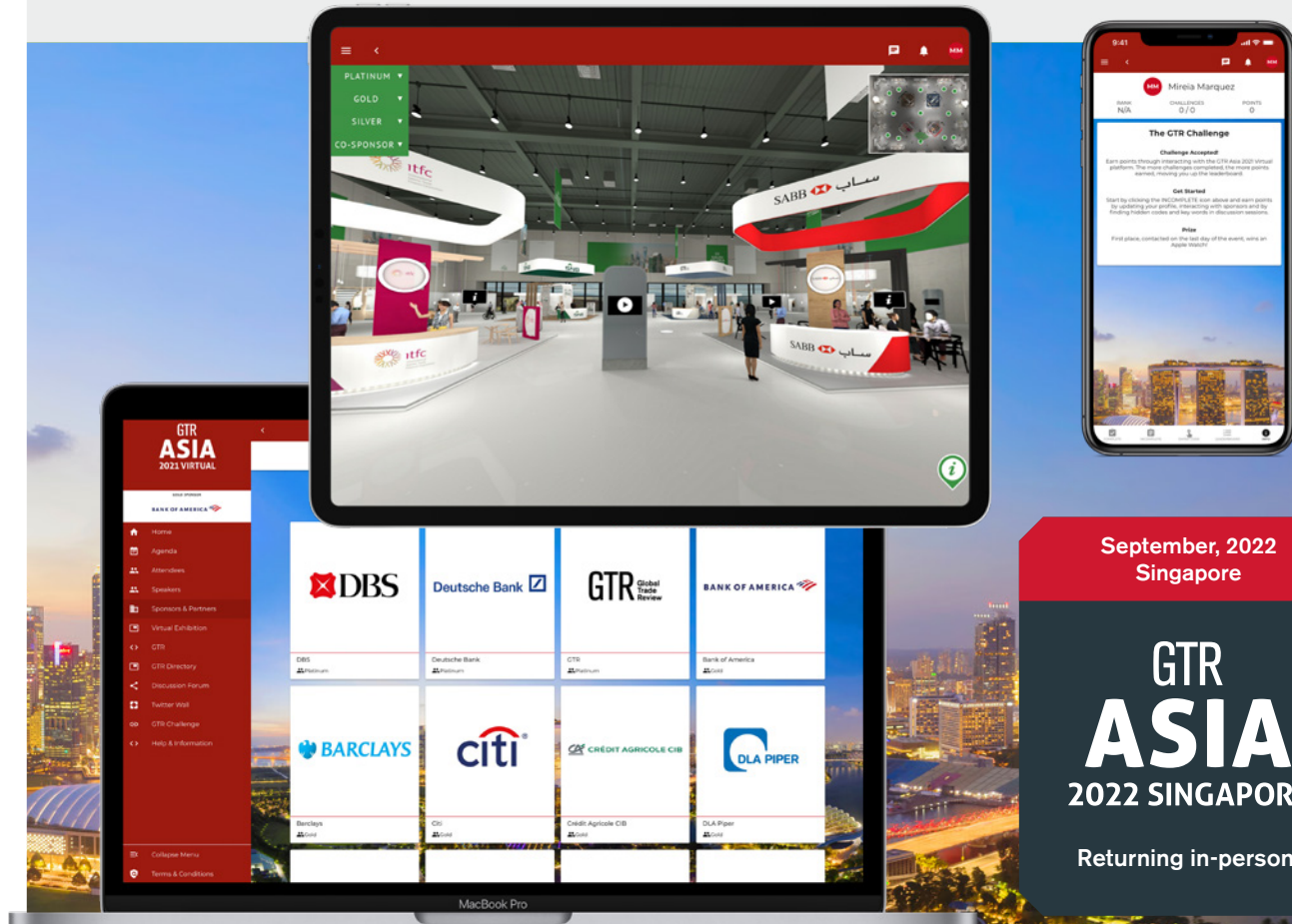
# GTR ASIA 2021 VIRTUAL

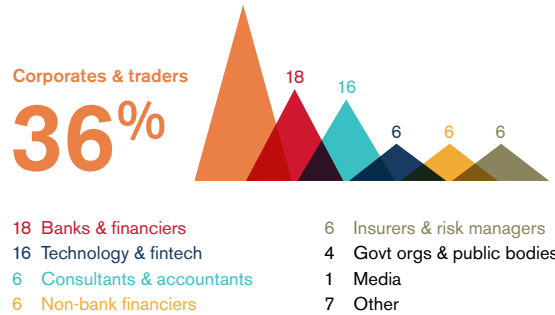

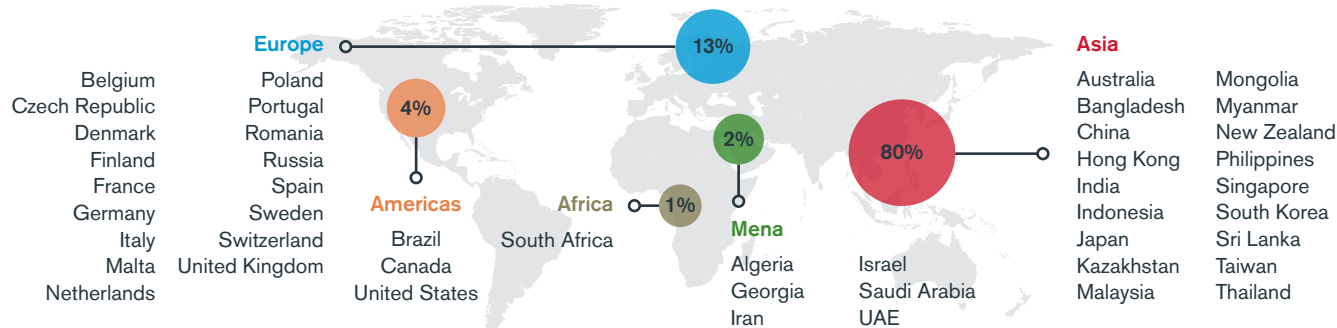
