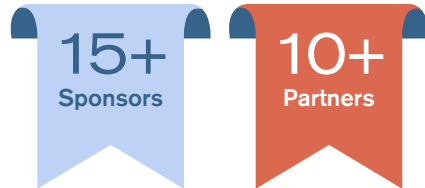

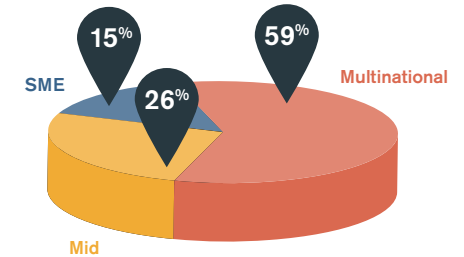

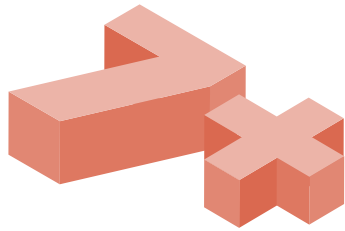
Attendees by sector in 2020



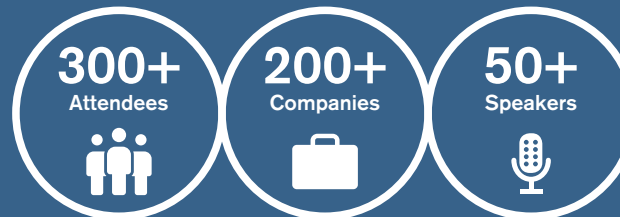
Company size breakdown in 2020

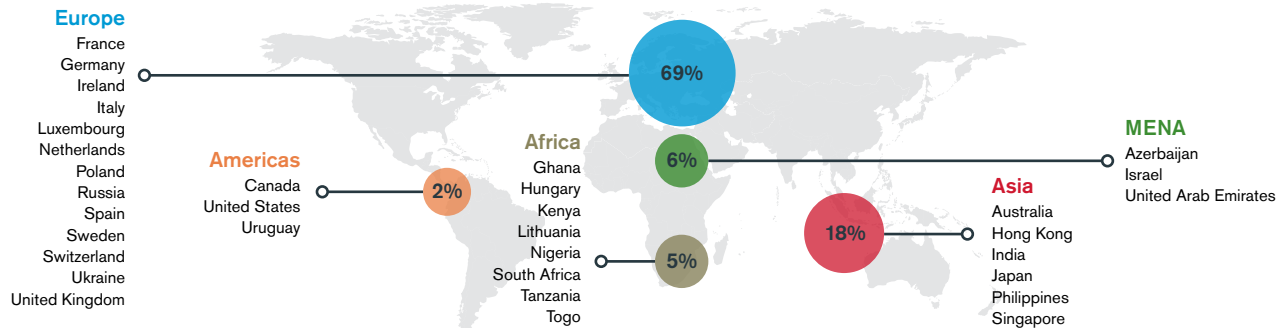
