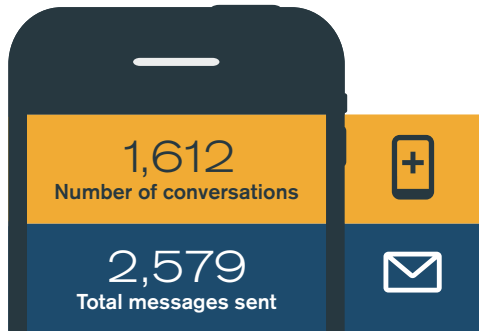

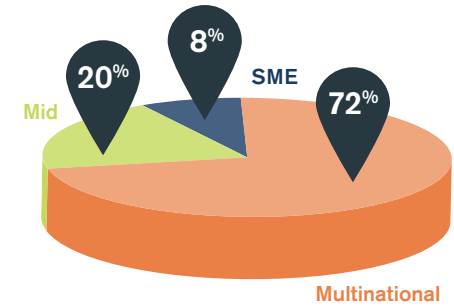

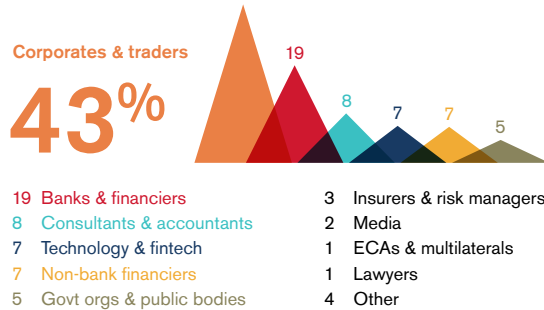

Company size breakdown in 2021



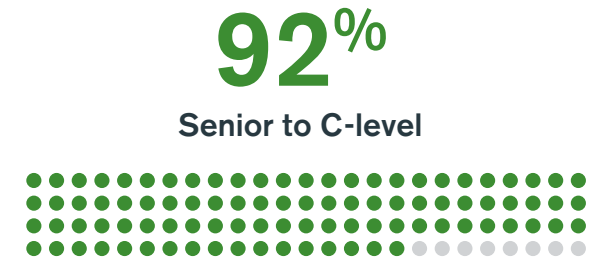
Attendees by sector in 2021

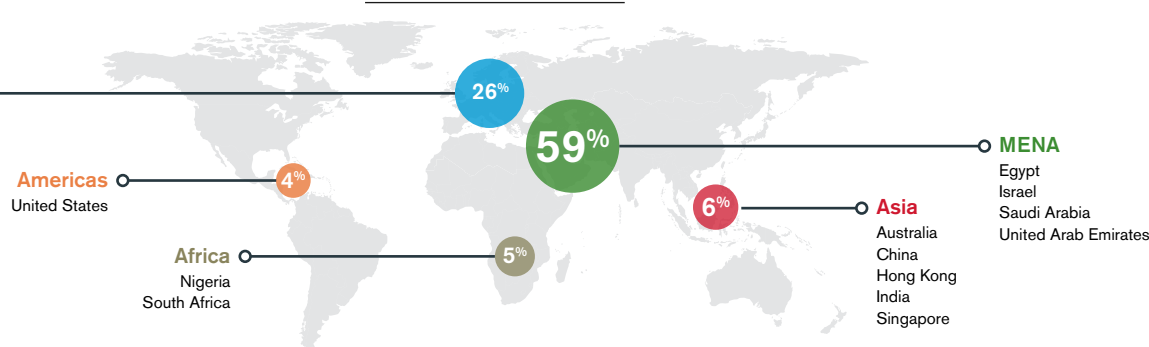

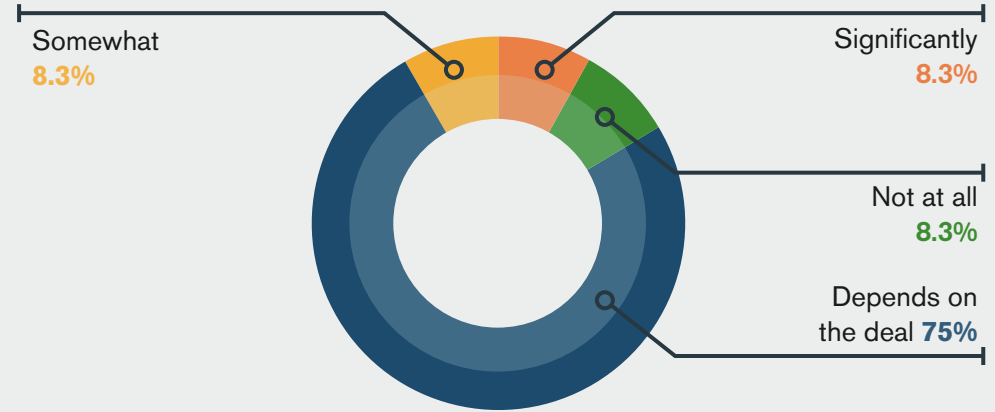

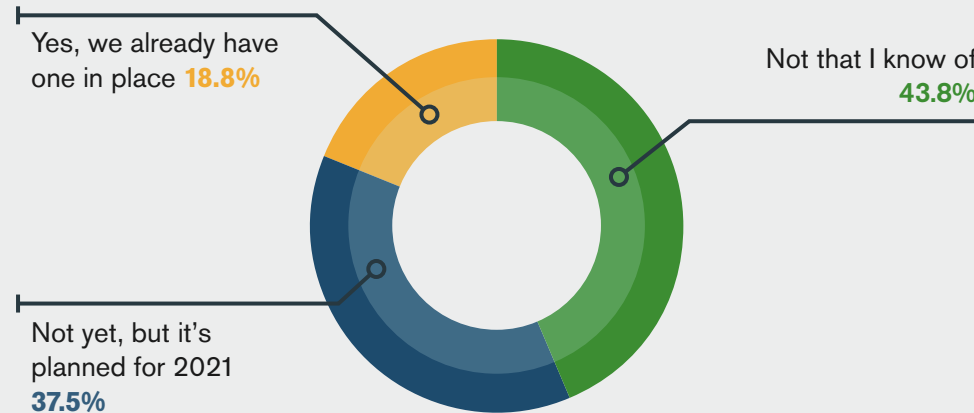
On a scale of 1-5, how would you rate the feasibility of fully digitising trade and trade finance within the next 5 years?



To what extent does lack of transparency in the region help/hinder trade finance?

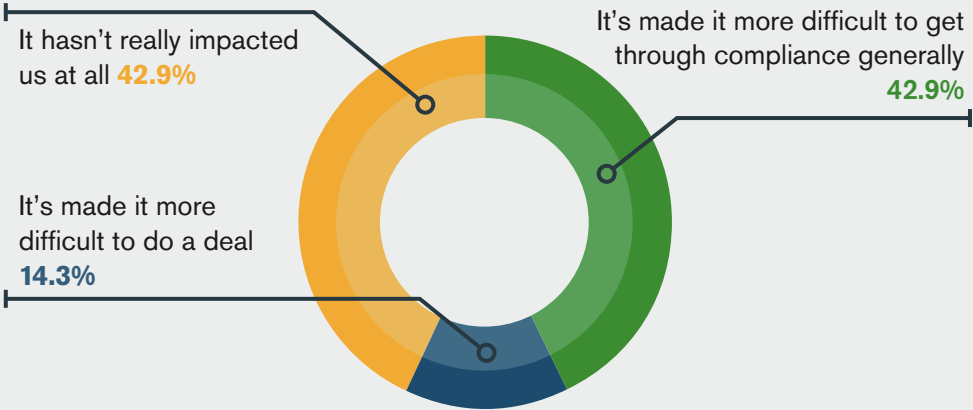


Has your finance team implemented a sustainability linked line of credit for 2021?

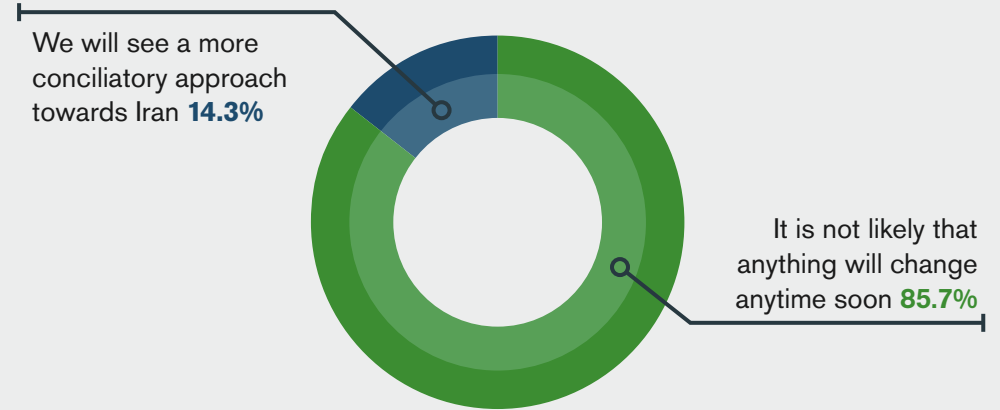

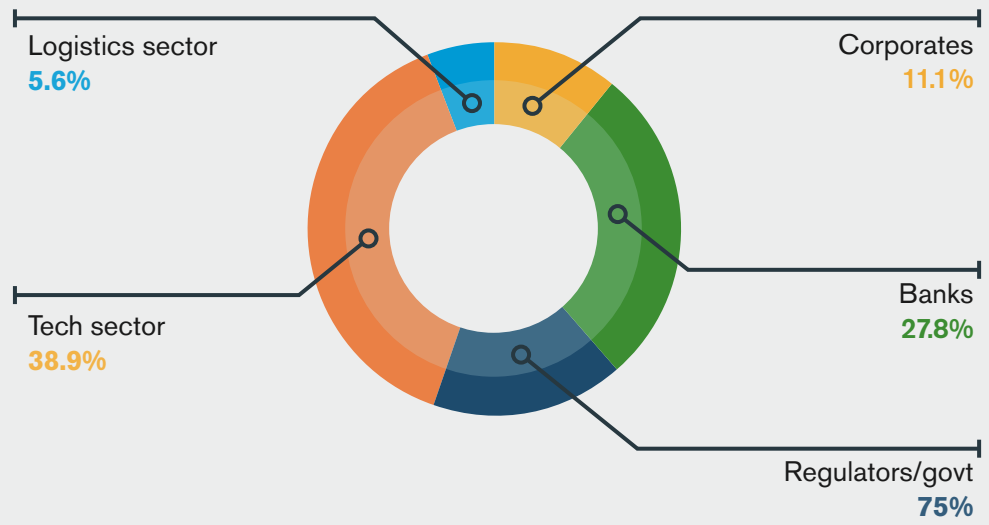
How has the sanctions regime impacted your business?
