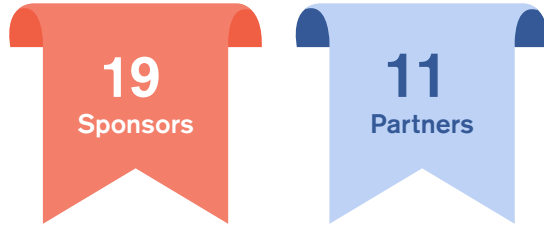

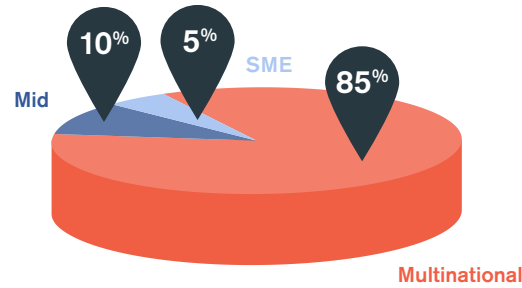

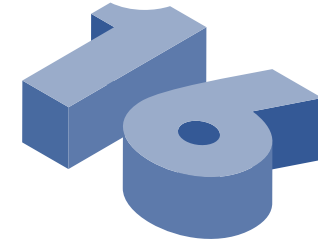
Total supporters in 2021



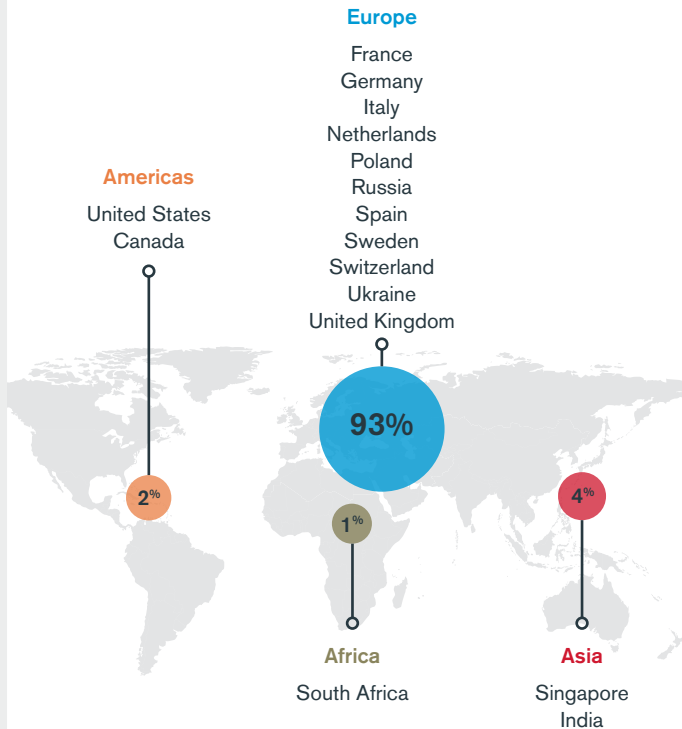
Company size breakdown in 2021

Attendees by region in 2021



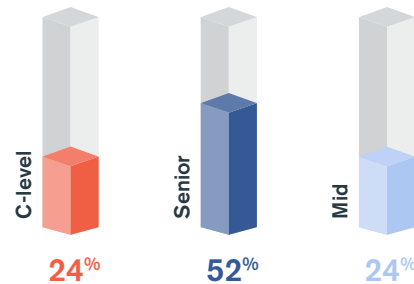
