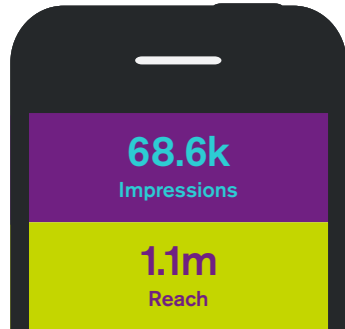

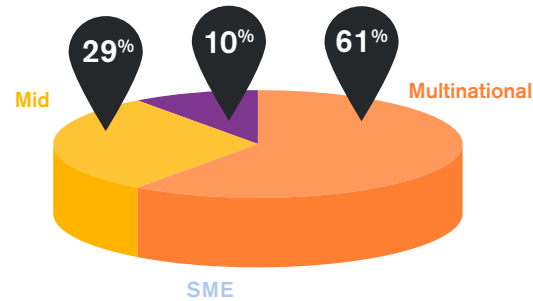

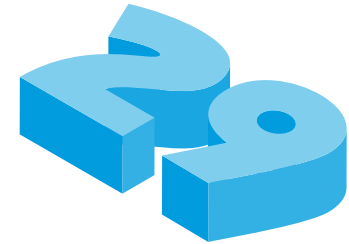
Social media stats in 2022



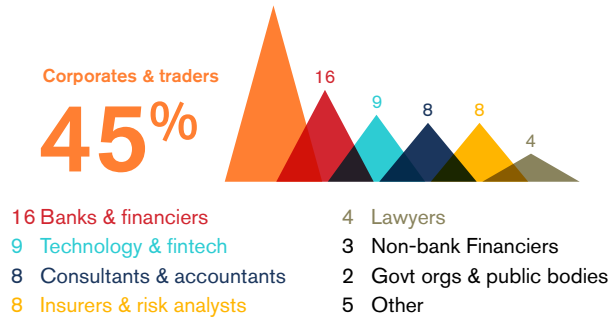
Company size represented in 2022



Countries represented in 2022



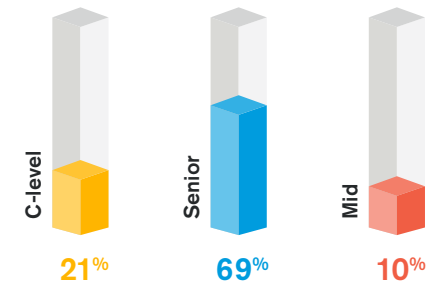
Attendees by sector in 2022



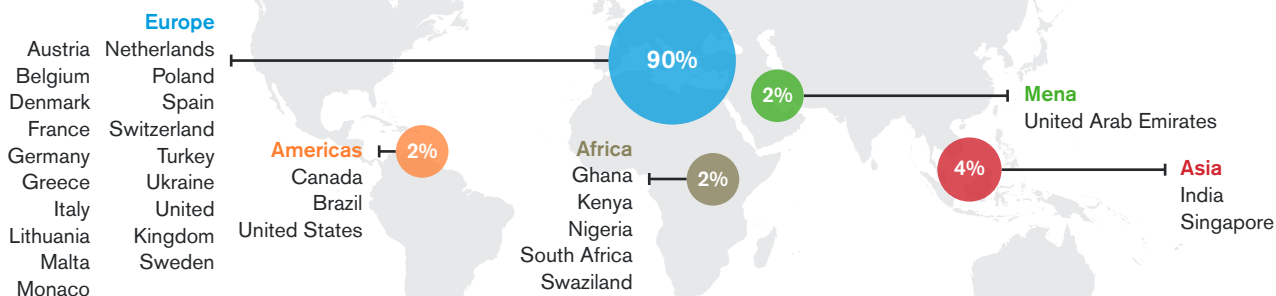
