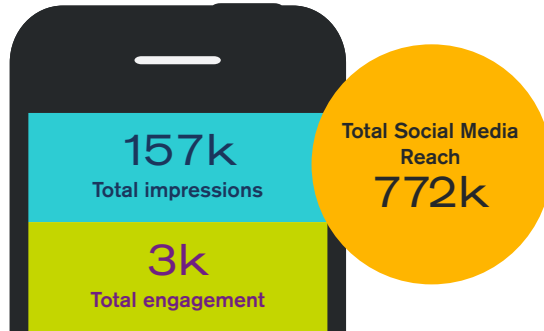

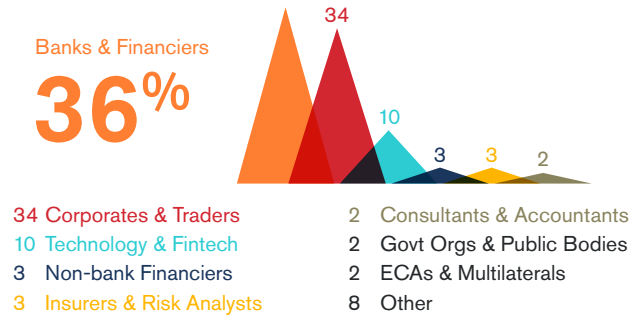

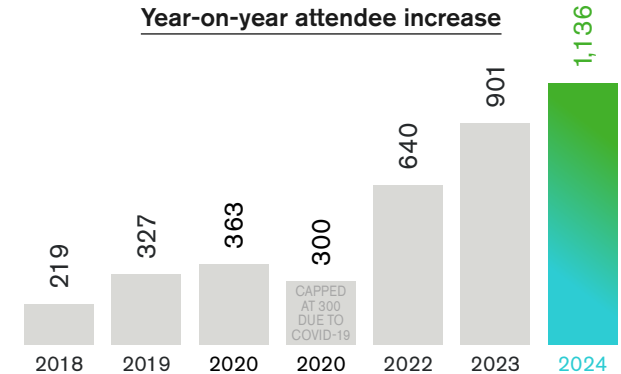
Social media engagement in 2024



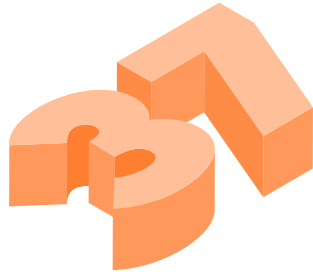
Attendees by sector in 2024



Year-on-year attendee increase



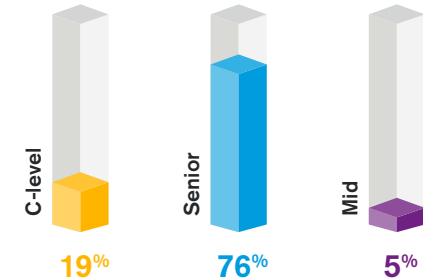
Countries represented in 2024



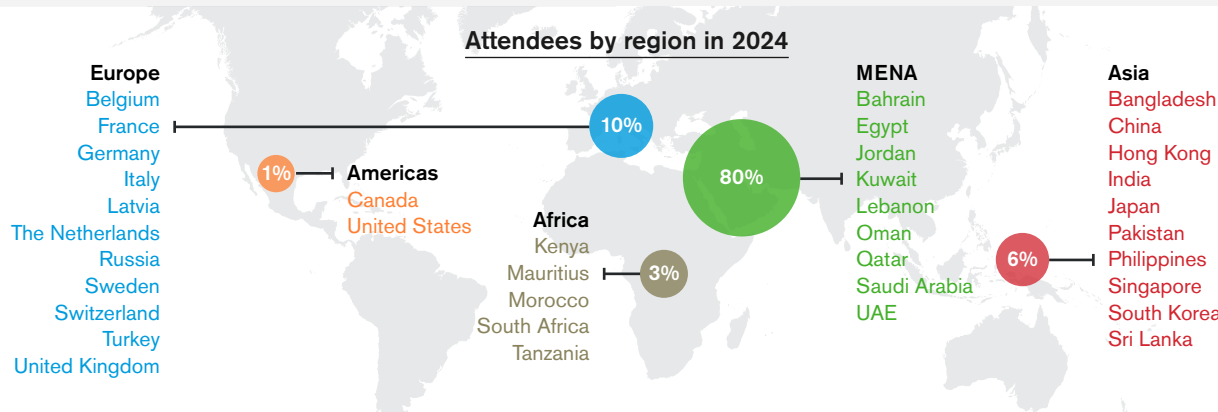
Vital statistics in 2024
