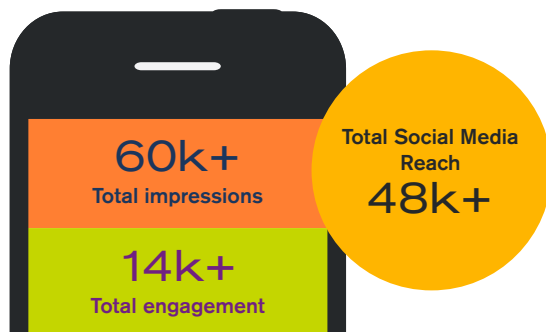

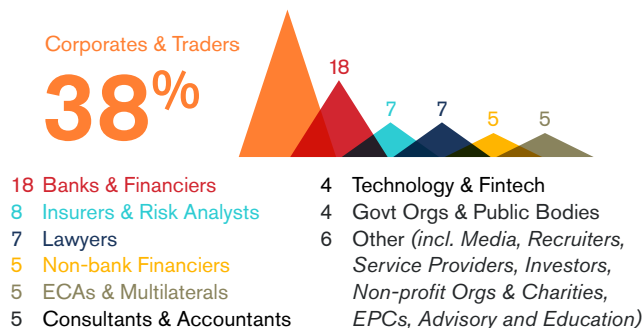

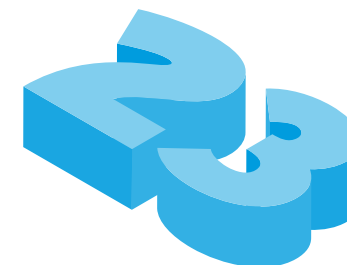
Social media engagement in 2024



Attendees by sector in 2024



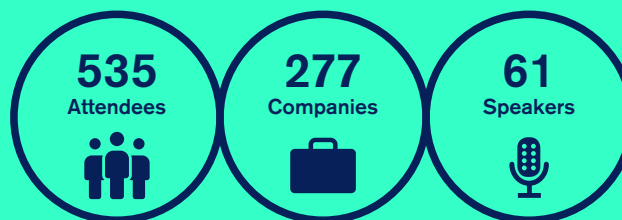

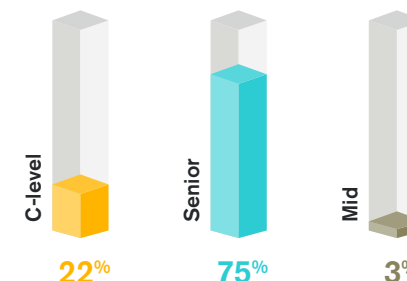
Countries represented in 2024



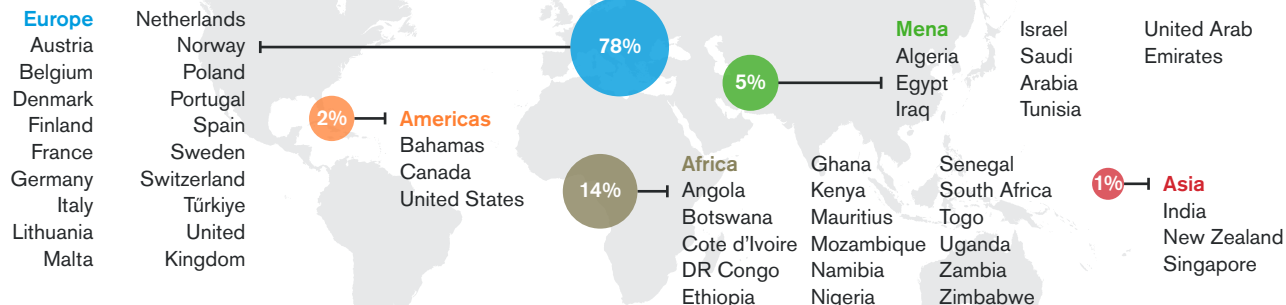
