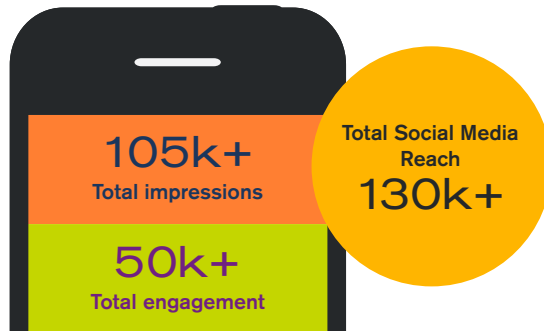

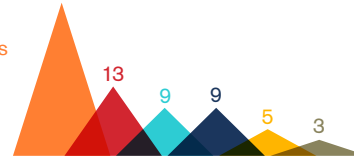

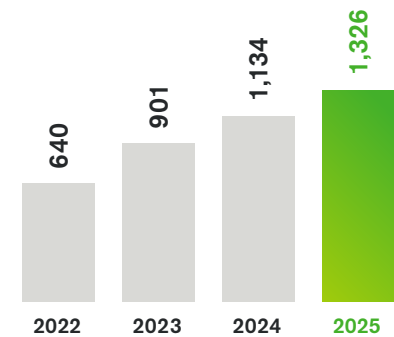

Year-on-year attendee increase



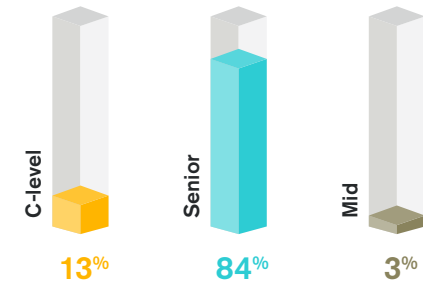
Countries represented in 2025



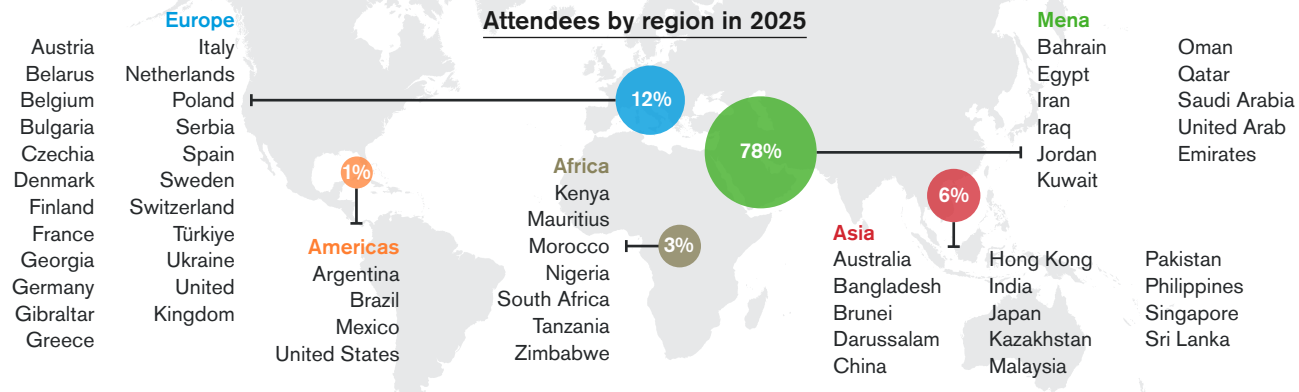
Vital statistics in 2025
