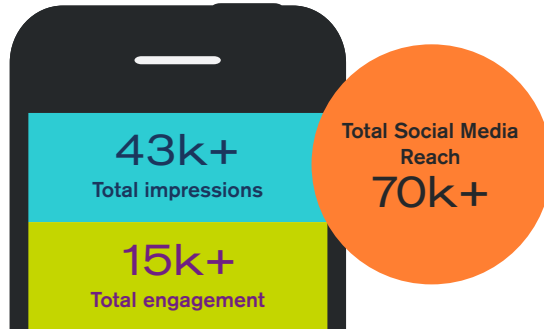

Social media engagement in 2025



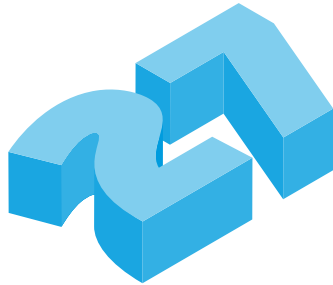
Attendees by sector in 2025

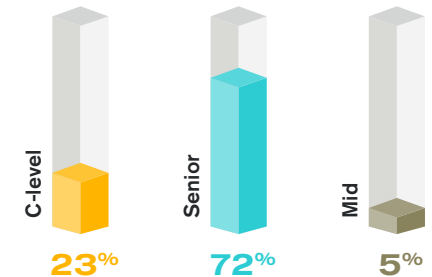
Countries represented in 2025

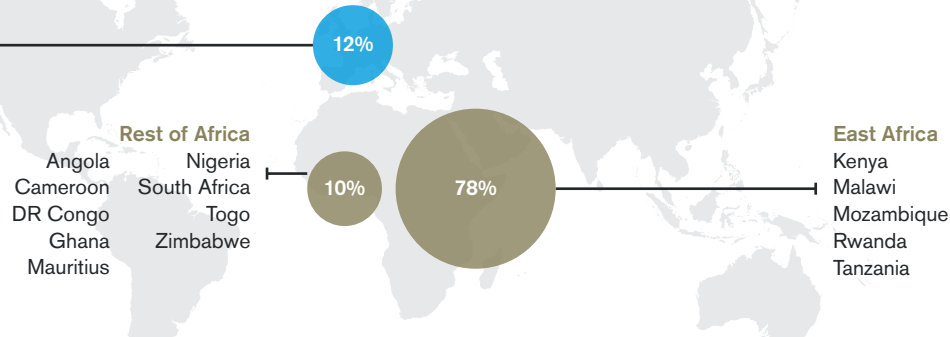

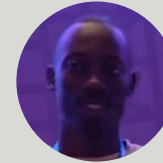
